## Goals, Issues & Policy Objectives

1.) Why are you running for office?

**I've known I wanted to be in law enforcement. I've been in law enforcement for 35 years and worked for the Sheriff's Department for 33 years. The breakdown of trust between the Sheriff's Dept. and our communities is unfair to county residents and makes it harder for our deputies to do their jobs. The conditions in our jails and other facilities are unacceptable. I retired in 2018, but I don't want to leave the Sheriff's Department in its current condition. We need to restore accountability and rebuild trust.**

2.) Why are you seeking endorsement from the Imperial Beach Democratic Club?

**The Sheriff's job is to enforce the law on behalf of all residents of San Diego County. I share the values of the Imperial Beach Democratic Club members, which serves as a collective voice for all IB residence. Endorsement by the Club communicates and demonstrates a specific set of values and priorities to the voters whose support I'm seeking.**

3.) List your top three policy agenda goals for your campaign:

**Transparency & accountability**

**Equitable & respectful policing in ALL neighborhoods, w/ focus on youth outreach**

**Address jail deaths & failure to meet health & disease standards in county jails**

**Transparency & accountability start at the top. I will be accessible and will engage constituents, organizations, journalists and others who have too often been ignored or disregarded. I will report accurate crime stats, whether or not they are positive for the department.**

**Equitable policing will require a change in culture. I will lead by example and work to ensure we are recruiting a police force that looks more like the communities we are policing. We must train and retrain deputies and work to dispel the "us vs them" mentality among deputies and residents.**

**I will implement the recommendations of the Grand Jury, CDC, and other organizations who have weighed in, but whose advice has been rejected by the current leadership.**

**I support climate justice and believe that climate change is real. We are environmentally conscious in our household when it comes to the products and energy we use.**

**Sheriff's Department assets include a large number of buildings and other physical facilities, plus a huge fleet of vehicles. Currently, only one building has solar panels. All physical facilities should be outfitted with solar panels (where feasible). Solar canopies can be built over our parking lots to produce energy while keeping vehicles cooler. All of this can be built, installed, and maintained by union workers. We also need to shift more of our vehicle fleet toward hybrid and electric models including our fleet of diesel buses. These changes would be a good start.**

6.) What do you think the relationship between ICE and the Sheriff's department should be?

**Sheriff's Deputies are not immigration officers and in accord with law & policy**

**should not question immigration status while performing their duties. Sheriff's**

**Dept. should not be coordinating with ICE nor releasing anyone to ICE. Hundreds**

**of people have told the Sheriff's Dept their cooperation with ICE creates fear and mistrust within the immigrant community. Sheriff's cooperation with ICE has never been shown to decrease crime but the opposite. When victims/witness are afraid to report crimes, crime continues.**

7.) Inmate mortality rates in San Diego County jails are among the highest in the State of California. Why do you think this is and what would you do to change this trajectory?

**First thing we need to do is change the status quo at the Sheriff's Department. The current leadership have all failed us. Implement #TakeItToZero Campaign to end all deaths in our jails. We will mitigate jail deaths by establishing a Task Force to perform a comprehensive evaluation of jail policies and procedures, staffing positions, and custody data to understand the root causes of the record number of deaths in the jails. Prioritize women's health and wellbeing in jails by meeting and exceeding standards for women's health and disease prevention in jails, including banning the use of shackling pregnant female inmates to their beds while they are delivering their babies. Prioritize mental health and harm prevention in jails by implementing proper mental health and risk assessment protocols for inmates to prevent the record number of inmate suicides and self-harm in our jails. Enforce transparency by implementing body worn cameras for all deputies, including deputies working in the jails**

8.) Data shows that between fiscal years 2019 and 2021, the Sheriff's contract grew by 14 percent while Imperial Beach City revenues only grew by 4.5 percent. In order to fully fund law enforcement, Imperial Beach has had to cut back on community services and even decrease the Fire Department's budget. What are your thoughts on this?

**The escalating costs for law enforcement are not sustainable. A lot of the unpredictability of costs to contract cities is overtime. The City of IB as a contractor for law enforcement by the Sheriff should expect better accountability. I would insist specific data points included in all contracts with cities so they can see what they are paying for. The Sheriff should be encouraging other than law enforcement response to community quality of life issues. The Sheriff must fix and maintain the moral and set expectations that will dramatically reduce overtime costs/litigation settlements.**
