 - In addition, Anna W opened the floor to any nominations including self nominations for any of the EBoard positions. Jen Crumley nominated Paloma Aguirre for Vice President, duly 2nd, and Paloma A nominated Jen C for Secetary, duly 2nd. And Marti E self-nominated herself for Outreach and she remained unopposed.

5. Other than the positions of Vice President and Secretary, the remaining positions as well as Outreach (above) were **accepted** without

opposition. The candidates for the **2 remaining contested** Officer positions were then provided the opportunity to address the attending members and guests followed by a brief Q&A for each one. The candidates were then asked to move to a neutral room in order to facilitate discussion among the remaining members either in support of or in opposition to any one of the candidates. When various Club members offered comments for and against candidates while the candidates were in their neutral place, Elsie Sleeter offered to step down to permit one of them to take her place. This statement by Elsie Sleeter was not considered as an appropriate for or against discussion of a candidates, the votes were collected and the vote tally was conducted by Sandy Brillhart and Anne Pilgrim. The tally **results** are as follows:

Secretary - Jen C 12 votes, and Antonio M 13 votes with 1 blank for Secretary listed twice by the talliers as "abstain" and "nobody". The remainder of the "nobody" ballot, which included a vote for Paloma A for VP, was counted in her VP total of 15.

Vice President - Paloma A, 15 votes, Ernie G,11 votes.

In addition there was 1 vote each for Paloma A and Jen C as a Member at Large, which was not a contested officer position. The slate of officers was accepted without opposition as represented above by the votes.
